# The St. Joseph Community Health Foundation Announces \$556,144 in Local Support with 57 Grants in First Half of 2019

Continuing their commitment to helping assure vulnerable populations are treated with dignity, and have access to quality health care (Mind, Body and Spirit), the St. Joseph Community Health Foundation announced that the Board approved an additional \$556,144 in local support. The funding is focused on four areas of significant local need: Prenatal & Infant Health, Food Insecurity, Access to Quality Affordable Healthcare, and Immigrant & Refugees.

The St. Joe Foundation is an independent, faith-based organization sponsored by the Poor Handmaids of Jesus Christ, who have had an active ministry in this community for 151 years. Through the St. Joe Foundation, the Poor Handmaids have invested \$20,829,207 through 1,434 grants into 230 Allen County agencies since 1998. All funding and programming continues the work started by Saint Katharina Kasper who was canonized by Pope Francis in Rome in October of 2018.

In addition to providing grants, the St. Joe Foundation also provides programming to address gaps in services, including a Resource Directory of Allen County's low-cost, quality healthcare resources. The Resource Directory is available online at <a href="https://www.HealthcareDirectory.org">www.HealthcareDirectory.org</a>. They also co-sponsor, with Parkview Health, the HEAL program, with farm markets in food desert neighborhoods, and the Our HEALing Kitchen free cooking classes, teaching how to prepare easy, high-nutrition meals and snacks.

The following grants are among those that have been funded from January through May 2019:

#### **Health & Wellness Support for Vulnerable Populations:**

Impact Area: Prenatal & Infant Health: \$183,000 in Support to 2 Agencies
A Mother's Hope \$33,000 (18-month grant)

To subcontract with Headwaters Counseling to provide counseling to the residents, and as a matching grant of \$2 for each \$1 pledged, to assist with fundraising efforts.

#### **Healthier Moms and Babies**

\$150,000 (Collateral Loan)

\$150,000 provided as collateral, to enable Healthier Moms and Babies to establish a line of credit to assist in managing new governmental contracts to expand services, and establish a new fiscal

## Impact Area: Immigrant & Refugee Health: \$102,500 in Support to 3 Agencies

#### **Allen County Department of Health**

\$47,500

For refugee interpretation, translation and outreach program assistance.

## **Amani Family Services**

\$45,000

For the Community Support Service Area, which provides mental health assessments, individual counseling, bi-cultural adjustment groups, and substance use support services to immigrants and refugees.

## **Lutheran Agency for Missions to Burmese (LAMB)**

\$10,000

To provide medical advocacy for Burmese people in Fort Wayne.

## Impact Area: Access to Affordable Care for Mind, Body & Spirit: \$189,000 to 9 Agencies

Associated Churches of Fort Wayne and Allen County \$20,000

For The Landing, to address spiritual and emotional needs of young people ages 13 - 19.

Brightpoint \$7,500

For the Covering Kids and Families Program, to assist uninsured Allen County residents in applying for, maintaining, and utilizing health coverage to increase access to quality healthcare services.

#### **Community Transportation Network**

\$35,000

For Medical Transportation Service, which assists seniors and people with disabilities in accessing medical appointments and services across Allen County.

## **Courageous Healing**

\$20,000

To help offset the cost of providing Restorative Trauma Intervention Groups and Restorative Family Interventions for low income individuals and families, and to purchase necessary supplies.

#### **Headwaters Counseling**

\$45,000

To provide necessary and high-quality mental health services to the poor and underserved at the Headwaters Counseling facility and at designated outreach facilities.

#### **Northeast Indiana Positive Resource Connection**

\$40,000 (2-year grant)

To provide free HIV and Hepatitis C testing and access for Pre-Exposure Prophylaxis (PrEP) for high-risk HIV negative individuals, and linkage to care and care coordination services to persons living with HIV/AIDS.

SCAN \$10,000

For Master's-level therapists to provide clinical services in the Family Preservation Program.

#### **Society of St. Vincent DePaul**

\$1,500

For operating costs of the CareVan, to transport people to and from medical appointments.

#### **Youth for Christ**

\$10,000

For the City Life Indigenous Leaders program, serving high school students in Southeast Fort Wayne.

#### Impact Area: Food Insecurity: \$63,280 to 36 Agencies

For two Shop, Cook and Eat classes in 2019.

\$1.500
