2022 SPRING GRANT GUIDELINES

APPLICATIONS FOR GRANTS OF \$5,000 OR MORE ARE DUE BY MARCH 1, 2022

ELIGIBILITY

- Applicants should be 501(c)3 non-profit organizations, focus on residents of Allen County, Indiana, demonstrate that at least 51% of their clients are very low income, and have a demonstrated history of serving vulnerable populations. Proposals that make a greater impact on a high percentage of lower-income, lower-resourced individuals are prioritized.
